We would be very pleased for Modern College of Arts, Science and Commerce, Ganeshkhind to offer a BSc (Blended) Chemistry program from this academic year. As the Program expands and our student cohort grows, the University is committed to ensuring that each student will graduate with a degree of the highest quality. To this end, from July 2019, the University with the support of SPPU, will be requesting that all institutions offering the BSc (Blended) degree to its students pay a levy of 10% of the student fee per year for the provision of quality assurance and curriculum development. Institutions newly offering the Program will also pay a one-off implementation levy.

The levies will be kept in India and used for the enrichment of BSc (Blended) through initiatives such as professional development training programs for the lecturers and, possibly, for scholarship programs. Please see details of the levies at the end of this letter, noting that the University will shortly provide Modern College of Arts, Science and Commerce, Ganeshkhind with a detailed term sheet to formalise the new arrangements. The BSc (Blended) is The University of Melbourne's premier undergraduate teaching and learning initiatives in India. Integral to its success has been the support of Savitribai Phule Pune University (SPPU) and Modern College for the Program during its pilot period, from 2016 - 2019.

The first cohort will graduate this month. I am gratified to note that each graduate will be an outstanding ambassador for SPPU, Modern College and for The University of Melbourne, with their strong foundational training in STEM and capabilities and communication skills that are testament to the unique structure of their degree that augments on-campus learning with field experiences, practical activities and contact with world class academics in India and in Australia.

In 2018, the University was delighted to host 18 BSc (Blended) BioSciences students and two teachers from Modern College for a special Research Camp, 'Applications of Cell and Molecular Biology in the Biological Sciences'. Alongside the intensive academic sessions, the students gained an insight into the University's engagement with India, met with Australian animals at a national park and experienced Melbourne culture. Bachelor of Science (Blended) License Agreement Summary

The University of Melbourne (UoM) will issue all Colleges affiliated with Savitribai Phule Pune University (SPPU) who are already/newly implementing the Bachelor of Science (Blended) degree, with a licensing agreement to enable the payment of annual levies to the UoM for the use of UoM's licensed materials to support the ongoing viability of the Program through provision of quality assurance, content management and delivery, and ongoing curriculum support.

Levies will include an Annual Quality Assurance, Curriculum Development and Content Management (QA/CD/CM) Levy and a One-off Upfront Implementation (IMP) Levy for all SPPU affiliated Colleges newly implementing the Program. **Modern College of Arts, Science, and Commerce, Shivajinagar (**Modern College) will be exempted from payment of the IMP Levy. Details of levies and financial arrangements are below.

SPPU has endorsed all financial arrangements.

Financial Arrangements

Levies	The levies will include the following:
	 Annual Quality Assurance, Curriculum Development and Content Management (QA/CD/CM) Levy: 10%/yr/student
	 One-off Upfront Implementation (IMP) Levy: AUD2000 Levy applies to SPPU's affiliated Colleges newly implementing the Program and will be payable upon sign-up; Levy will be used by UoM to run annual professional development workshops for the staff teaching the Program and to offer scholarships to the students when transiting into UoM (3rd year or MSc).
