First Round Admission Notice

- The First round Allotment List of the candidates (General and Reservation) for admission to M.Sc. (Computer Science) and M.Sc. (Computer Application) Part –I is available on the websites of both the colleges and on modern.epravesh.com link.
- The admission to M.Sc. (Computer Science) and M.Sc. (Computer Application) Part –I classes have been allotted strictly on the basis of score in the Entrance Exam and as per rules of reservation.
- Candidates should confirm their admission by completing the remaining procedure and depositing fees on the link provided on the College Website before **Friday, 7th August 2020.**
- Approximate fees are Rs. 62,050/- per year
- If the candidate does not complete the admission process by **Friday, 7th August 2020,** his/ her admission will stand cancelled and will not have any claim on admission in the next round.
- Please note that, you have been provisionally admitted to particular course during academic year 2020-21. Your admission will be confirmed subject to fulfillment of Eligibility criteria.
- Transfer of admission between either Colleges may be possible depending on the number of seats available after the First Round of Admission and if the candidate has given choice for transfer earlier in the 'Student Information' Google form.
- On the basis of vacancies, if any after the first round, the Second Round Allotment List will be displayed on the College Website and modern.epravesh.com on **Monday, 10th August at 3.00 PM**
- The date of commencement of course(currently online) is **Monday, 17th August 2020**

Cancellation of Admission and Refund of Fees

For the candidates who cancel their admission before starting the course for the relevant academic year, his/her entire fees after deduction of processing fee of not more than Rs. 1000/- shall be refunded to the student by the university/concerned Institution.

If the student cancel his/her admission after the course is started, following scheme will be adopted for refund of total fees:

Sr. No.	Time of Cancellation	If, vacant seat has been filled by another candidate before last date – amount to be deducted
1	From 1 st day to 10 days (First day inclusive) from the date of commencement of the course.	20 % of the total fees
2	From 11 th day to 30 days from the date of commencement (First day is inclusive) of the course.	40 % of the total fees
3	After 30 Days (First day is inclusive)	100 % of the fees
